Minutes of: Regular Meeting August 26th, 2020 – 5:30p.m.

The duly called and noticed meeting of the City of Fairmont Human Rights Commission was held on Wednesday, August 26th, 2020 at 5:30 p.m., via Zoom.

Brett White, Commission Chairperson, called the meeting to order and asked for a roll call of members.

In RE: Approval of Meeting Minutes from 7/22/20: Minutes were sent out for review by the commissioners prior to the meeting. No discussion took place.

In Re: Report from Committee on Education and Community Forum:

- Jim Nolan reviewed structures of discussion that were put together during our workshop in December 2019.

- Jim Norton updated the commission on the Building Bridges of Respect event and Fairmotn City training.
 - o Still exploring workshop opportunities for BBoR.
 - Most immediate concern is assisting the Communities of Shalom with the cultural competency training.
 - o Funding for the training has been approved.
 - Hope to come back to the HRC with a couple of different formats for the BBoR event.

- O Communities of Shalom purchased "How to be an Anti-Racist" for all City Council members.
- DD Meighen
 - O Spoke about the plan to introduce some ciriculum for Marion Co. Schools to use about county history with human/civil rights.
 - o Recognized that today signified 100 years of women's right to vote.
 - He is looking for funding for the ciriculum.

In Re: Update on City of Fairmont Employee Training Progress:

- Tony Michael and Denis Scott from WVU were on the call
 - o Tony said that training customization has started.
 - o Communities of Shalom was able to secure all costs through grant funding
 - o Planning to try to deliver the training in person in smaller groups
 - o Hoping for late Sept./early Oct.
 - o The next step is to make the connection with the City Manager about scheduling/location/etc.

In Re: Discussion of Lack of Diversity on Human Rights Commission:

- Brett White reminded everyone that the entire commission agrees with the problem with the lack of diversity on the commission.
 - O Stated we don't have the power to make those changes ourselves.
- Gia Deasy clarified that we all applied, but that we were chosen and that it seems as thought the procedure itself is flawed and was not advertised enough.
- Cyndi Straight pointed out that she is a minority.
 - O Stated that she would gladly give up her seat.
 - o All terms expire on November 15, 2021 at the same time
- Gia suggested advertising openings to try to diversify the group.
- Marianne Moran explained the process of choosing commission members
 - o City Manager and Council see all application.
 - City Manager choses their picks and they have to be approved by Council.
- Brett brought up the suggestion of having 3 commission members resign in November to free up seats for new applicants.
- Gia suggested that the paragraph section of the application could be the place where applicants can speak to diversity and their personal experiences.
- Brett reiterated the difficulty that the commission has had in getting the word our about meetings and other things we are doing.
- Jim Nolan suggested adding recruiting efforts to our education efforts. He is willing to do that as part of the education group.
- Brett suggested that we need to let Council know that they need to do better with a more diverse group when appointing members.
- Dani DeVito suggested that one of the commission members go to a Council meeting and update the Council on the complaints that the commission has received about the lack to diversity.

- Larry Buckland said that he was willing to address Council with the issue at the next meeting.
- Commission also began a discussion on if additional fields of Name and Email Address by required on the Google Form.
 - Decided that it was best to leave the form anonymous.
- Dani suggested having any of our statements moving forward read into the record at City Council meetings.
- Dani also suggested having Larry also inform Council that, as a way to add more diversity to the commission and stagger our terms, 3 members of commission would be stepping down in November.
